THOSE CHILDREN WHO GET SAFE, NURTURING PLAY AND LEARNING EXPERIENCES ARE READY FOR SCHOOL; THOSE THAT DON'T ARE MOST OFTEN THE ONES WHO START BEHIND AND STAY BEHIND. 55% OF WA CHILDREN ARE NOT PREPARED TO ENTER KINDERGARTEN AND THE PERCENTAGE RISES TO 75% AMONG LOW INCOME CHILDREN. FOR THOSE WHO ARE LOW INCOME OR HOMELESS, THERE ARE DEEPER LEVEL OF SERVICES TO HELP THEM ACCESS RESOURCES AND FINANCIAL ASSISTANCE.
